Subject: BMS Notification regarding ADW Mileage

Dear ADW Providers,

Recently a change was made in regards to transportation codes utilized by Behavior Health Providers. Some of you may have received a message from Molina when verifying an ADW member's eligibility that states that ADW miles are limited to 500 miles a month and must be prior-authorized.

Please note that at this time, no prior authorization is required in order to bill A0160 for miles utilized when providing ADW services nor is there a 500 mile per ADW member per month cap.
